In every sense of the word, last year was a good year with Catholic Charities. With the support of our donors and grantors, we were able to serve 14,000 families and 45,000 individuals, a sign of the increased need coming to us and of increased resources as well. Client evaluations are an aspect of non-profit best practices. Our client evaluations indicate that clients feel respected and have their needs addressed and show us they leave with hope. What you will see and read in this report are some of the facts, stories and photos from our daily work which serve as

description and accountability to you. These exemplify the two feet of charity and justice and the core programs of Catholic Charities: Peace and Justice/Respect Life, including Parish Social Ministry; Emergency Assistance; Family Support; and Counseling.

Our staff, along with hundreds of volunteers, continued to provide the skilled, compassionate service which must always be the hallmark of Catholic Charities. During this year, we realized effective growth and faced the challenges that come with it especially in a time of diminishing resources from several sources. We developed our capacity through the integration of the data base into the daily functioning of staff, thereby making our ability to measure outcomes more precise. We deepened our skills through agency training on financial management, poverty, parish social ministry, our Codes of Ethics, countless procedural and practice issues.

One of our most comprehensive program efforts has been in Parish Social Ministry (PSM). As a result, PSM leaders from parishes are now meeting on a deanery basis. The Parish Social Ministry Regional Training was held in Raleigh in September, 2007, and our diocesan conference in Newton Grove in October, 2008. Requests for Emergency Assistance are skyrocketing. Some of our clients come to us directly for Family Support Services. Others are referred to the continuum of services from Emergency Assistance in

order to meet numerous other unmet needs. Our Counseling services have expanded in seven deaneries and into the Newton Grove deanery this year, meeting our stated target of providing both Spanish/English counseling services throughout the diocese.

What can we see for Catholic Charities now? The hungry are more numerous, many asking for help for the first time in their lives. What we face now is a period of creative stabilization, stretching our resources and strategically planning for the years ahead. We are faithful to the call to serve. While Catholic Charities is motivated by our faith as expressed through Catholic Social Teaching, we are also a part of a broader faith-based

Social Teaching, we are also a part of a broader faith-based mission and a world wide common cause of people of good will. We are connected in all that we do. We are connected in the power of faith, the assurance of hope and the demonstration of love in the God whom we trust and who entrusts to us this mission in our time and place. You are an integral part of this connection and our mission. Thank you for your prayers, friendship and support.

# Program Spotlight: Parish Social Ministry

Our work in Parish Social Ministry (PSM) grows stronger each year. This program is an integral part of Catholic Charities mission: to assist the parishes, communities and Diocese of Raleigh in accomplishing the social mission of the church. In its roles of servant, advocate, facilitator and convener, Catholic Charities acts in the parish and community-at-large to heighten awareness of issues and, when appropriate, provides services to fulfill unmet needs. Catholic Charities serves people in need through advocating for social and economic justice as well as addressing immediate needs with emergency resources or direct services.

Work with the New Bern parish of St. Paul Catholic Church is a shining example of the fulfillment of our mission. Last year, parishioner Lilly Krcmar requested a consultation with Catholic Charities Regional Director Linda McAlister and Sr. Joan Jurski of the Office of Peace and Justice/Respect Life. Lilly intended to develop ways in which her parish community could become more aware of social justice issues. By availing herself of the education and training resources of our agency and obtaining the support of her pastor, Lilly was able to involve her fellow parishioners in issues such as immigration and hunger.

St. Paul's group invited Sr. Joan to give a "welcoming the stranger" immigration talk to about 60 people. After her visit there, Sr. Joan remarked the parish group "felt strengthened" to embark upon more activities and advocacy for



justice, not only in their community, but around the globe.

Their latest focus is on world hunger. St. Paul's group did a Bread for the World project that involved the parish in a letter-writing campaign to elected officials seeking an end to world hunger.

Sr. Joan affirms the Church's position that is written in Communities of Salt and Light: "The parish is where the Church lives." Facilitating the results that individuals and parishes are looking to accomplish, Sr. Joan finds progress being made in many parishes in our diocese: "What Catholic Charities does is connect with the passions of those seeking to do justice and promote peace. We provide guidance along with resources to affirm their efforts."




their God-given potential to the fullest. As a volunteer myself, let me invite you to consider volunteering at the Catholic Charities office nearest you.

# Catholic Charities Celebrates Grand Opening of Food Pantry and Family Center: CPO/CPFH

The largest food pantry serving Wake County's hungry opened at a larger facility in November. Bishop Burbidge and other dignitaries were on hand for the dedication attended by about 200 program volunteers and visitors.

With strong, direct financial support from parishes, Catholic Parish Outreach (CPO) has served the poor and most vulnerable among us for more than thirty years. #### 2008 John J. Carey Award Winners

The John J. Carey Award is given for outstanding contributions to social ministry in the Diocese of Raleigh and to persons showing a strong commitment to the Church's social mission. The award was initiated by the Board of Directors of Catholic Social Ministries in 1989 and named for its retiring director, John J. Carey, who was the first recipient.

Catholic Charities of the Diocese of Raleigh presented its annual John J. Carey Award to Charles Giordano and James Scharenbrock of St. Brendan the Navigator Church in Shallotte, NC. Eight years ago, the men started selling plants they had raised from seedlings in their homes to benefit St.

Brendan's Loaves and Fishes program to feed the poor. Their operation has grown to the point where they have a greenhouse and support not only programs through St. Brendan's but through various faith communities in Brunswick County, as well as Habitat for Humanity. Last year Mr. Giordano and Mr. Scharenbrock raised more than \$20,000 for the poor.

### IRA ROLLOVER EXTENSION

#### Use Your IRA as Never Before: To Make a Gift to Catholic Charities

On August 17, 2006, President Bush signed into law The Pension Protection Act of 2006 that encourages financial support of charitable organizations across the United States. The new legislation offers a welcome incentive to donors who want to use the money in their IRAs to make charitable gifts. On Oct.ober 3, 2008, Congress passed and the President signed the Emergency Economic Stabilization Act of 2008 (H.R. 1424), legislation that includes a two-year extension of the IRA charitable rollover. The provision was extended on October 3, 2008 and is retroactive to January 1, 2008. It expires on December 31, 2009

How the New Law Works: The IRA rollover provision allows charitable distributions of up to \$100,000 from an IRA or a Roth IRA to be excluded from your gross income. In addition, the amount rolled over will count against a donor's minimum distribution requirement. As in previous versions of IRA rollover legislation, there is no federal income tax deduction available for these contributions in addition to their exclusion from income.

You may contribute funds this way if:

- You are age 70½ or older
- The gift is \$100,000 or less each year
- I You make the gift on or before December 31, 2009
- You transfer funds directly from an IRA or Rollover IRA to the charity
- You transfer the gift outright to one or more public charities; rollovers to a planned gift, such as a gift annuity or a charitable remainder trust, do not qualify.

**Example of How The New Law Works:** Edith, aged 80, has \$450,000 in an IRA and has pledged to give \$75,000 to her church this year. If Edith transfers \$75,000 from the IRA, she will avoid paying income tax on that amount. She cannot, however, claim a charitable deduction—it is a pure "wash." Edith has found an easy way to benefit her church without tax complications. If she desires, Edith could give more than \$100,000 because the legislation allows a maximum \$100,000 gift in both the 2008 and 2009 tax years. If her spouse has an IRA and is 70½ or older, he can also give up to \$100,000 each year.
